

**FIRST EVANGELICAL LUTHERAN
CHURCH ENDOWMENT FUND
GRANT
APPLICATION**

First Evangelical Lutheran Church, Greensboro, N. C., established a General Endowment Fund in 1990. The purpose of this fund is to enhance the mission of First Evangelical Lutheran Church (FLC) apart from the general operation of the congregation. In 1996 the T. Moser Youth Fund was established as endowment specifically to be used for children and youth of First Lutheran Church.

Believing that Christian Stewardship involves the management of all the gifts God has given us, it is the desire of the congregation to encourage, receive and administer these gifts in accordance with the by-laws of this church. The by-laws state that income from the General Endowment fund may be distributed annually for the following purposes:

1. FLC Capital improvements and building programs
2. Outreach into Guilford County
3. Special Program and projects of this Congregation beyond the normal budget
4. Extended Mission work and benevolence including NC Synod Affiliations

The T. Moser Youth Fund can only be used for children and youth programs at First Lutheran Church.

Each year the Endowment Fund Committee determines the amount to be disbursed according to the by-laws.

Applications for the funds will be accepted from members of the congregation, pastors and staff, and church committees. In an effort to serve the needs in our community, not-for-profit organizations in Guilford County may also apply, co-sponsored by an FLC member. Applications can be downloaded from the church website, completed electronically, and returned to flcendowment@gmail.com. If a paper application is desired, it will be available in the church office for pick-up and return.

The Endowment Fund Committee has the final approval of all requests.

Below is the schedule of the annual grant allocation process for the Endowment Fund.
